1. Proposals are invited on behalf of **NOIDA GOLF COURSE SOCIETY (Regd.)** from eligible civil contractors for the work of 'Repair & Renovation of Civil I Works at Captain Shashikant Sharma Marg Sector 38, Noida, U.P. 201303.

CIVIL CONTRACTORS/FIRMS WHO HAVE CARRIED OUT SIMILAR WORK FOR COMMERCIAL ESTABLISHMENTS /INSTITUTIONAL WORK/GOVERNMENT DURING LAST THREE FINANCIAL YEARS. THE APPLYING FIRM SHOULD HAVE MINIMUM TURNOVER OF 30 LKAHS IN THE LAST FINANCIAL YEAR

- 1.1 The work is estimated to cost Rs. 34.54 lakhs

This estimate, however, is given merely as a rough guide.

- 1.1.1 All matters relating to invitation/award of proposals shall be dealt by Secretary Office, Noida Golf Course (NGC), Noida.

- 1.1.2 Financial proposal should be in the BOQ format as attached for each proposed work.

2. Agreement shall be drawn with the successful tenderer. Tenderer shall quote his rates as per various terms and conditions of the said tender which will form

part of the agreement.

3. The time allowed for carrying out the work will be 45 days after the date of issue of letter of acceptance of tender (Work Order) or from the first day of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
4. The site for the work is available.
5. The bidders will be informed about the date and time of opening the proposals as and when the opening date and time is decided by NGC.
